2019 WAS SIGNIFICANT because of the many important milestones we celebrated, such as the 100th anniversary of the Summer Reading Program and the Library Foundation's 50th year. But it also brought a clearer understanding of how impactful Library services are to individuals and our overall community.

A Library-commissioned study by Thomas P. Miller & Associates concluded that IndyPL provides the community a \$3 return in services for every \$1 of taxpayer investment. The analysis identified the large ripple effect of Library spending throughout the local economy, as well the monetary value of programs, services, and access to materials as perceived by Library users.

In 2019, our impact was clear! New and renovated branches are improving access to Library services. The Library continued its initiative to place Library cards in the hands of school students, giving them the resources they need for academic success. An enhanced staff compensation package was approved by the Library Board that more accurately reflects the market, ensures the retention of talent, and gives patrons the benefit of the highest levels of staff expertise. New leadership-level positions were created to guide our direction in the areas of diversity, inclusion and strategic planning.

Throughout this report, you'll see the impact of the Library Foundation in providing \$2.2 million in support for programming that is fundamental to the Library's mission. Our efforts to improve children's literacy, lifelong learning and cultural awareness would not be possible without the generous investments of the many individuals, companies and foundations whose impressive philanthropy is noted in this report's latter pages.

Please join us as we proudly reflect on our 2019 accomplishments. We also invite you to take advantage of several opportunities in 2020 to provide input as the Library embarks on a new strategic plan to identify service priorities and to continue impactful investments in Indianapolis.

A NOTE ON THE NUMBERS

In 2019, the Library began an ongoing effort to improve data collection and tracking to better understand patron usage, resulting in more accurate data for such service markers as patron visits, circulation, and attendance at programs. Circulation statistics for 2019 were impacted by new borrowing practices implemented to improve the Library experience for all patrons by reducing the number of times items can be renewed, as well as increasing the loan period for DVDs and Blu-ray discs. These practices will keep our vibrant collection of materials circulating and available for browsing and check out. As for Library cardholders, the 280,183 reflects all non-expired (valid) cardholders as of December 2019. Overall, these data collection and tracking efforts will ensure truer comparisons of yearly Library activity in the future.

Summer Reading Program

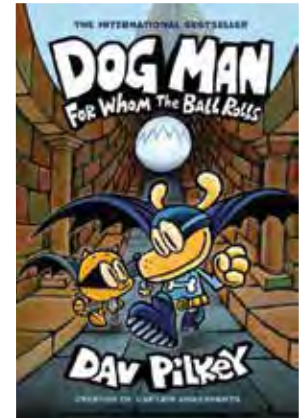
The Library's Summer Reading Program celebrated its 100th anniversary by attracting **46,040** registered children and families. Summer readers read **860,171** books.



As part of the lineup of free summer activities for kids, IndyPL presented fun and educational workshops and films for **20,035 ATTENDEES**.



The celebration gave participants a chance to share their favorite summer reading memories and vote on their **FAVORITE KIDS BOOK** from the past 100 years. The winner . . . the **DOG MAN SERIES** by Dav Pilkey.



IndyPL programming underscored a central tenet of the Library's mission: to build the literacy skills of children and stimulate their desire for learning.

Summer Reading Program

Ready to Read

This initiative helped young ones up to age five build a foundation for lifelong learning while providing outreach services to caregivers to foster kindergarten readiness.

On the Road to Reading visits by Outreach Services targeted 63 child care centers where **1,029 STORYTIMES** and **EARLY LITERACY PROGRAMS** were presented to **1,505** individual children.

1,132 new families participated in the “**1,000 BOOKS BY KINDERGARTEN**” program, and **105** children completed the **1,000-BOOK GOAL**.

In a new partnership with three eastside WIC (Women, Infants and Children) clinics, **1,000 FAMILIES** received bilingual board books, Library card applications and information on Library services to promote healthy child development.

940 FAMILIES attended “Reach Out and Read” Day at Central Library, a celebration of families reading and playing together.

621 EDUCATORS and child care providers attended Library workshops to promote best practices for storytelling and teaching early literacy skills.

Ready to Read

Ready to Read programming received more than \$285,000 from major sponsors including CollegeChoice 529 Direct Savings Plan; The Herbert Simon Family Foundation; Hoover Family Foundation; The Indianapolis Foundation Library Fund; Mr. and Mrs. Thomas Maurath; PNC Foundation; St. Vincent | Ascension; TCU Foundation and Friends of the Library.



Want to listen to a recorded story? The Library's 24-hour Call-a-Story telephone line (317-275-4444 or toll-free at 877-275-9007) received **171,494 CALLS**. Indiana Pacer players (pictured) were the most popular storytellers with **43,758 CALLS**.

- The Learning Curve at Central Library, a past winner of the American Library Association's Library of the Future Award for innovative children's programming, offered 1,209 programs with a total participation of **33,063**. Its **MEDIA WORKSHOPS** attracted **4,962 CHILDREN** and family participants throughout the year.

- More than **40,000 PUBLIC SCHOOL STUDENTS** in Perry, Pike and Wayne townships received **LIBRARY CARDS** as part of the Library's campaign to provide cards to all Marion County students. They join 75,000 other students who have gained access to the Library's wide range of electronic resources to help in their academic study.

- Highlighting the Library's increased emphasis on programming for teens was an appearance by National Book Award-winning poet and young adult author Elizabeth Acevedo. In 2019, the Library presented **590 TEEN PROGRAMS** attended by **13,339 TEENS**.



In 2019, the Library presented 6,763 programs for children and teens with a total attendance of 133,544.

Programming for all ages in 2019 reflected the Library’s commitment to help individuals achieve their lifelong learning goals and to serve as a catalyst in the growth and prosperity of Indianapolis.

Special Literary Events

Adults enjoyed their own **SUMMER READING PROGRAM**, “Favorite Fiction: Rebooted,” that provided a selected reading list of 15 titles featuring retold stories. Activities included book discussions, writing workshops, altered-book poetry programs, and a keynote presentation by Madeline Miller, bestselling author of the mythological retelling, “Circe.”

IndyPL played host to **INDIANA POET LAUREATE ADRIAN MATEJKA** who presented the workshop series, “Poetry for Indy,” supported by Indiana Humanites and held in the Center for Black Literature & Culture at Central Library.

Aspiring writers enhanced their skills, learned about publishing, and met notable Hoosier authors at **“MEET AN AUTHOR, BE AN AUTHOR”** at Central Library. Free workshops were presented by experts from the Indiana Writers Center.

The 42nd annual **MARIAN MCFADDEN MEMORIAL LECTURE** was presented at Clowes Memorial Hall at Butler University by National Book Award-winning author, journalist and graphic novelist Ta-Nehisi Coates.

Life Skills

Lifelong Learning

Adults developed more advanced technology and business skills at Coding for the Curious and Library Resources for Entrepreneurs at Central Library, and learned how to make rain barrels at Garfield Park's Earth Friendly Festival. Thanks goes to Comcast, Covanta, Office of the Lawrence Township Trustee Steve Talley, Regions Bank and Friends of the Library for nearly \$34,000 in support.

1 The Library's Career Centers offered free one-on-one help for those searching the job market or wanting to improve their computer skills. In 2019, 985 sessions with an **ATTENDANCE OF 3,001** served both the unemployed and underemployed.

2 IndyPL was a proud partner of Congressman André Carson's **6TH ANNUAL YOUTH OPPORTUNITIES FAIR** at Central Library. The event attracted **671** young people who learned about available jobs, internships and volunteer opportunities.

3 In an effort to embrace our increasingly diverse community, the Library hosted Natural Helpers from the Immigrant Welcome Center at several locations who helped approximately **200 NEWLY-ARRIVED CITIZENS** learn about Library services and assimilate into the local culture.

Unique Programming



Mexican wrestling at the Library? Hundreds were introduced to this genre known as Luche Libre during the **LUCHA LIBRO FESTIVAL** presented by La Sardina Gallery at Central Library. The Library's Atrium was transformed into an actual wrestling ring where the colorful masks and high-flying maneuvers of the luchadores took center stage.

HOT JAZZ FOR COOL KIDS, featuring some of Indy's leading musicians, filled the seats in Central Library's Clowes Auditorium. Free performances in the eighth year of the series provided a great way for parents to introduce children to jazz music that was fun for everyone!



Name a topic for a computer class and chances are the Library offered it!

Computer basics, graphic design, coding, advanced Microsoft applications, and downloading on one's mobile device were just some of the **521 FREE CLASSES** presented for **2,643 PARTICIPANTS**.

Classes for Spanish speakers also were presented.

From computer classes and author talks to musical programs and business workshops, the Library presented 12,471 free programs for adults with a total attendance of 234,678.

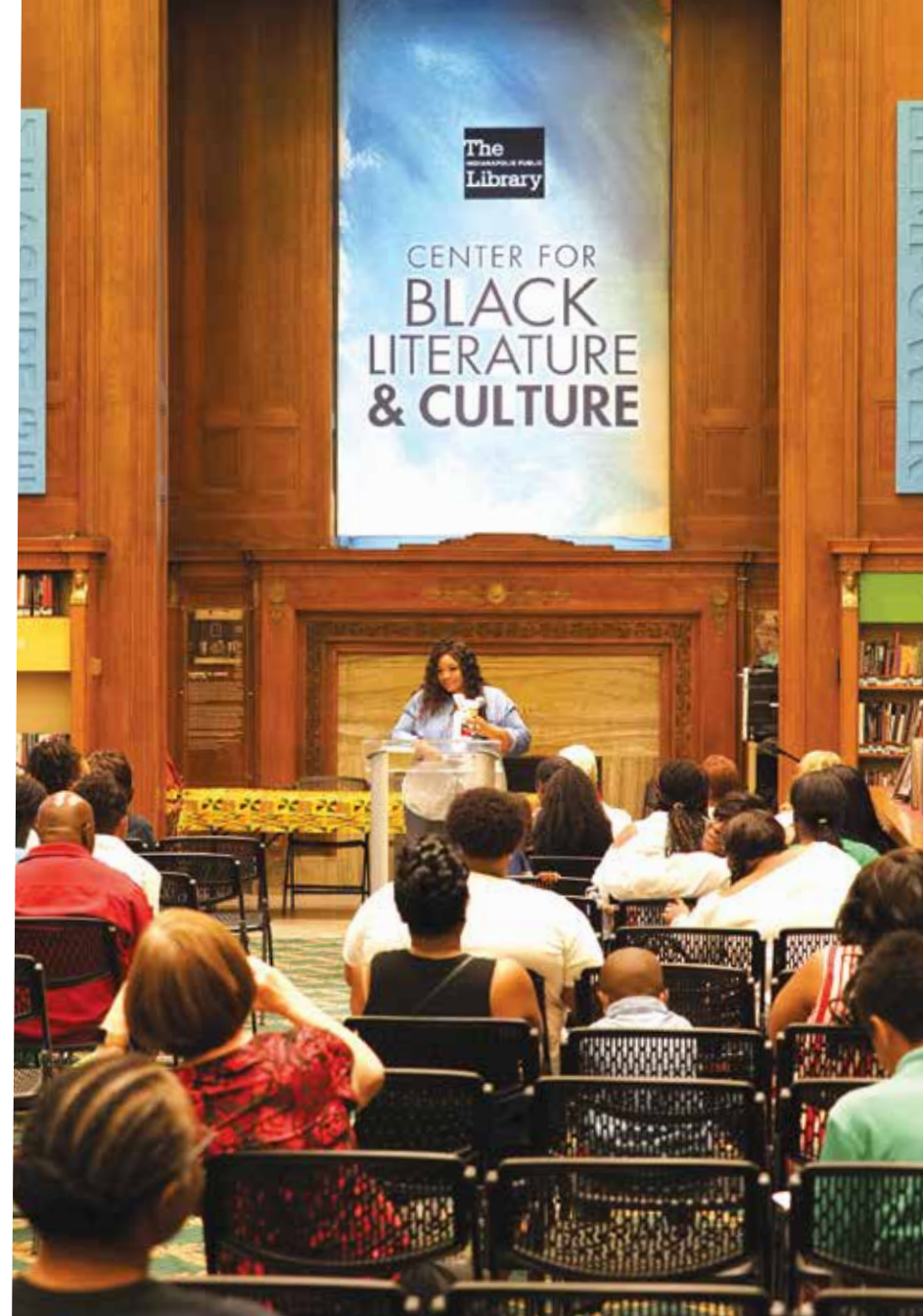


African American History Committee Events

The Center for Black Literature & Culture at Central Library celebrated its **SECOND ANNIVERSARY** with a tribute to Indianapolis great Oscar Robertson and the Crispus Attucks High School championship basketball teams of the 1950s. As a focal point for exploring the black experience in Indianapolis and beyond, the CBLC has welcomed more than 117,000 visitors to its interactive displays, engaging programs, and specialized collections.

African American History Committee programs

The Christel DeHaan Family Foundation, Donna D. Talley Story Theatre Fund and Friends of the Library contributed more than \$64,000 for programs that highlighted the African American community, including a film production camp for teens, the Meet the Artists exhibit and gala and Fall Fest. Many of these programs and events took place in Central Library's Center for Black Literature & Culture, a space dedicated to books by black authors or about the black experience. The Center for Black Literature & Culture was made possible through the generosity of Lilly Endowment Inc.





FALL FEST '19 featured the amazing 11-year-old "Step Stool Chef" Julian Frederick who dazzled young and old alike with his cooking acumen and story of becoming a food entrepreneur. His message empowered young people to be leaders in the kitchen. Fall Fest also featured the talented winners of the Teen Slammin' Rhymes Challenge.



Always a highlight on the cultural calendar, **MEET THE ARTISTS XXXI** featured the works of locally prominent African American artists. Its signature event was the free public Gala Reception at Central Library attended by an estimated **2,000 INDIVIDUALS**.

More than 10,000 artifacts of the Indianapolis Metropolitan Police Department and Indianapolis Fire Department, including log books, dispatch recordings, personnel records, newsletters and photos dating to the 1870s

CRISPUS ATTUCKS HIGH SCHOOL –

A collection of photos, letters and individual portraits of students who have attended the school since 1927, when it opened as the city's first and only all-black high school

BLACK HISTORY, INDIANAPOLIS HISTORY – A new repository of family photos and memorabilia from generations of local families obtained through “scan-a-thons” at several cultural heritage preservation events at Library and community locations

DECATUR HIGH SCHOOL YEARBOOKS –

Full-text editions of the “Hawkeye” dating from 1947, joining the yearbook collections of 21 other local high schools

Digital Indy

Pieces of history were digitized thanks to over \$150,000 in support from Lilly Endowment Inc., National Endowment for the Humanities and Friends of the Library.

Staff Devoted Energies to New ILS

Work continued toward the early 2020 transition to a new Integrated Library System (ILS), a **MANAGEMENT SYSTEM** that identifies and unifies all catalog and patron records in a single database. Kudos to all staff for persevering through this exhaustive process!

New Borrowing Practices

1

The change from an essentially unlimited number of renewals to a limit of 10 allows materials to be available to a larger number of patrons. The goal is to keep items circulating and ensure that a vibrant collection of books is available for browsing and checkout.

2

Patrons now have more time to enjoy newer DVDs and Blu-ray discs resulting from an increase in their loan period to seven days. Items that already had a 21-day loan limit, including children's DVDs, were not impacted.

3

The late fee for DVDs was reduced to 25 cents to match the late fee for books.

4

Allowable checkouts for electronic materials were reduced from 35 to 20. Items that can be placed on hold were reduced from 20 to 10 at one time. The intent is to reduce wait lists and unwanted checkouts, provide access to more patrons, and help the Library manage its materials budget.

A New Website

At the start of 2019, the Library launched a redesigned, mobile-friendly website featuring an easy-to-use catalog, robust calendar for events and programming, and improved access to the Library's many online offerings.

Shared System

The Library's Shared System, a coalition of 46 local schools who share their collections with each other and Library patrons, created **4,487 NEW LIBRARY CARDS** for its students.

Because of the partnership with IndyPL, **300 YOUNG STUDENTS** at Christel House Academy South were the first in the city to receive hardcover copies of Jeff Kinney's newest book in the *Diary of a Wimpy Kid* series, *Wrecking Ball*.

EAGLE BRANCH



The Library progressed in its long-range plan for the strategic distribution of branches in convenient locations to maximize the public's access to services.

New Openings

A larger children's area, more patron seating, new shelving for book displays and a new single entrance point are among the features of the **NEWLY-RENOVATED BEECH GROVE BRANCH**. The changes allow the branch to offer expanded services to better meet the Beech Grove community's needs.

The **ELMIRA ANNIS CIVIC PLAZA** opened on the grounds of the Irvington Branch, made possible by a grant from the R.B. Annis Educational Foundation in memory of Elmira Annis. The outdoor plaza is a beautifully-landscaped common space for music concerts, civic events and Library programming. The plaza is graced by four art pieces created by students at the IUPUI Herron School of Art and Design.

On June 1, 2019, the entire community celebrated the **GRAND OPENING** of the new **EAGLE BRANCH** at 3905 Moller Road. The 20,700-square-foot branch replaced the smaller branch in the Eagledale neighborhood that had served patrons since 1970. An important design feature is an array of solar panels that provide 75% of the branch's electricity needs.



BEECH GROVE BRANCH



ELMIRA ANNIS CIVIC PLAZA

Capital improvements identified in the Library's long-range plan are funded from individual bonds approved by the Indianapolis City-County Council with no increase in the Library's debt service tax rate.

Coming Soon

BRIGHTWOOD BRANCH



Anticipation grows toward the completion of the new **BRIGHTWOOD BRANCH** at 2434 N. Sherman Drive, scheduled for **OPENING IN MAY 2020**. It will replace the storefront branch located across the street that has served the community since 1972.

WEST PERRY BRANCH



Following a series of citizen input meetings, design plans were unveiled for the new \$9.2 million **WEST PERRY BRANCH**. The 25,000-square-foot branch will be located at 6650 S. Harding St. and will fill a large geographical service gap on Indy's south side. **GROUNDBREAKING IS SCHEDULED FOR APRIL 14, 2020.**

The **WAYNE BRANCH** closed in December 2019 as construction began on its first major renovation since the 13,300-square-foot building opened in 1983. The \$1.5 million project will be completed in mid-2020.

Beginning in January 2020, the **LAWRENCE BRANCH** also closed for a \$1.5 million renovation, the first since its 1983 opening. The 13,300-square-foot facility will re-open in mid-2020.

Impressive!



The new **EAGLE BRANCH** received a high honor in energy and resource conservation with the distinguished **LEED GOLD CERTIFICATION** from the U.S. Green Building Council. The branch's efficient technologies will save the Library over \$10,000 per year.



The historic **EAST WASHINGTON BRANCH**, which reopened following a comprehensive renovation in 2018, received **LEED V4 CERTIFICATION** in 2019 for its energy efficiency and environmental design. Improvements to this Carnegie Library resulted in significant natural lighting, reduced water consumption, and more efficient heating and cooling. Solar panels also were added as part of the renovation.



The **MICHIGAN ROAD BRANCH**, which opened in December 2018, earned these prestigious awards in 2019. . .

- American Institute of Architects (AIA) Indiana presented krM Architecture with the Honor Award for New Construction.
- AIA Indianapolis presented krM Architecture with the Merit Award for Interior Design.
- krM Architecture also received the Indiana Chamber's Monumental Honor Award for Architecture.
- The Indiana Chapter of the International Interior Design Association awarded its IDEA Award to Indy Urban Hardwood Company for its efforts to repurpose trees from the Michigan Road property for many of the branch's interior furnishings.

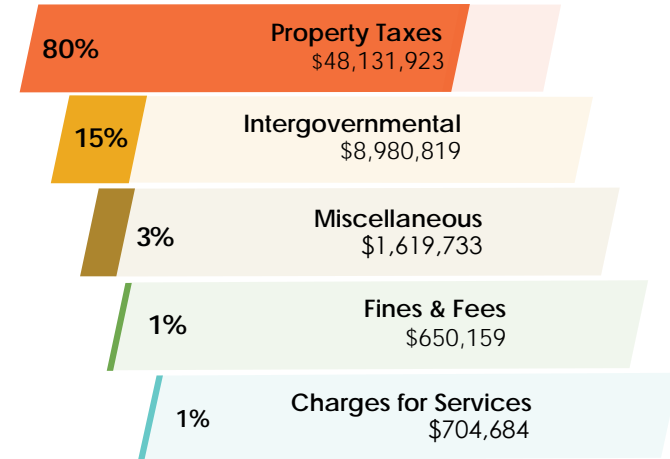

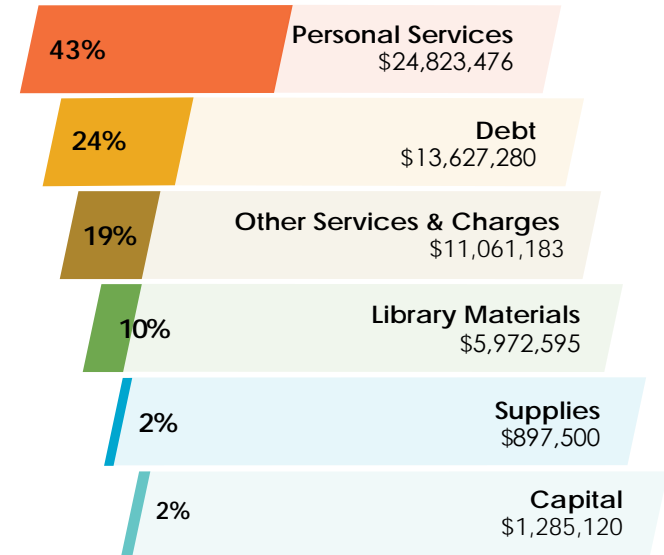

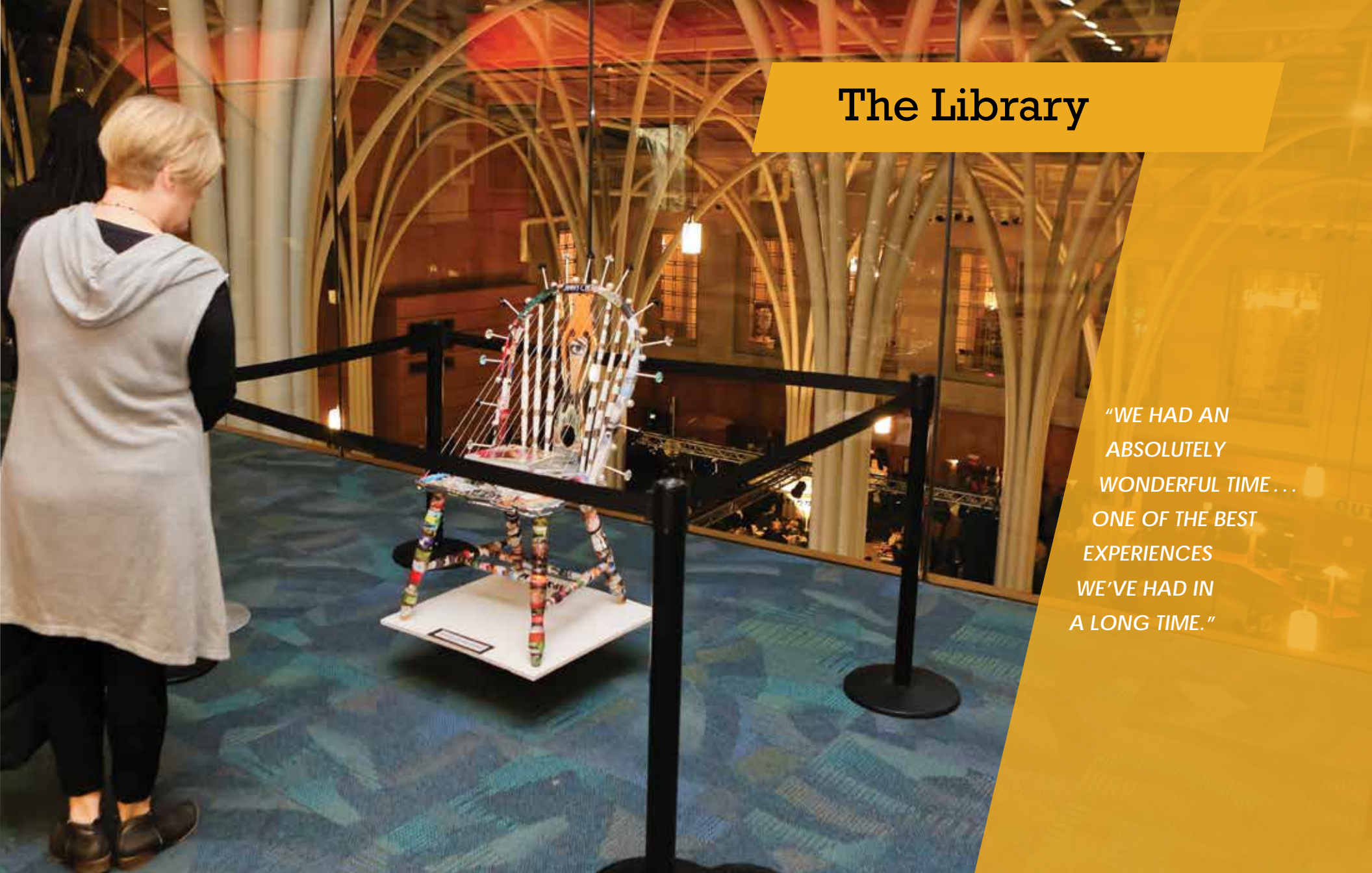
EXPENDITURES // \$57,667,154
